Product Description: Kincrome Knives and Muli-Tool



Reason for Bulletin:

New laws come into effect in Queensland from 1 September 2024 meaning knives and other items will be considered controlled items.

Also note other states will follow shortly.

Requirements of the Knife Laws:

Knives and other controlled items cannot be sold to anyone under the age of 18.

- Sellers must display signage about age restriction requirements.
- Staff must be instructed and warned of their obligations, with written acknowledgement.
- Controlled items must not be promoted or advertised as suitable for combat.
- Certain controlled items, such as double-edged knives, machetes, tomahawks, and axes, must be securely stored prior to sale.

Exempt from Knife Laws:

It is also worth being aware that there is some exempt product to this legislation.

Kincrome does not have any products that are exempt from the new knife laws:

- (a) a plastic or wooden knife designed to be used for eating; or
- (b) a knife with a rounded or dull edge (i.e a butter knife); or
- (c) a knife designed for use as a cheese knife



Affected Products

Controlled Single-edged knives or multi-tools with knives on the same side must not be sold to minors, but are not required to be securely stored, unless this is the policy of your business Kincrome model numbers affected

Controlled-Secured items are required by law to be securely stored: double-edged knives, knives with blades at both ends, axes, tomahawks, machetes, sickles, scythes, swords, spears, spear guns and gel blasters which look like real firearms.
